Apart from session cookies, the presence of cookies Google Analytics allows us to collect information in an anonymous format for aggregated statistics that allow us to analyse some aspects of navigation on our site.

PURPOSE OF THE TREATMENT

Our company processes your personal data as defined above and indicated for the purposes illustrated below and according to the basis of lawfulness referred to in the RGPD and on the side specified.

- To respond to specific requests from visitors to the site (RGPD, Article 6, paragraph 1, letter b) and for the relative sending of information and / or material;
- For the pursuit of the legitimate interests of the owners (RGPD, Article 6, paragraph 1, letter f). By way of example and not exhaustive:

DATA PROCESSING PLACE AND PROCESSING METHOD

Your data are processed in the Italian territory. All operations (collection, processing, consultation, printing, archiving, modification, updating, deletion, non-exhaustive list) may be carried out on paper or by electronic means.

COMMUNICATION OF YOUR DATA TO THIRD PARTIES

The Data Controller has entrusted the development and maintenance services of the site to a specialized supplier, specifically appointed as independent Data Controller; the site and the mail domain used for receiving visitors' requests and sending information are managed hosted by IDEOO di Lodetti Tullio within the territory of the European Union.

Your personal data will not be disclosed to other subjects.

DATA CONSERVATION PERIOD

The data collected for the purposes described in point A "PURPOSE OF TREATMENT" will be kept:

- For the exchange of information and / or materials and will be cancelled no later than 12 months after the last sending of information and / or materials by the Data Controller;
- For the whole period necessary to provide the "reserved area" service and will be cancelled within 2 (two) weeks from the closure of your reserved area.

YOUR RIGHTS

- Right of access to personal data concerning you, pursuant to Article 15 of the RGPD;
- Right to rectify your personal data, pursuant to Article 16 of the RGPD;
- Right to delete your personal data, pursuant to Article 17 of the RGPD;
- Right to limit the processing of your personal data, pursuant to Article 18 of the RGPD;
- Pursuant to Article 19 of the RGPD "Obligation to notify in case of rectification or deletion of personal data or limitation of processing";
- Right to object to the processing of your personal data, pursuant to Article 21 of the RGPD.
